1. VANTAGE TRADING LTD. PRIVACY AND SECURITY POLICY

Vantage Trading Ltd. ("we", "us" or "Vantage Trading"), is a company registered in Mauritius and whose Registered Office is at c/o Legacy Capital Co Ltd, Suite 201, Level 2, The Catalyst, 40 Silicon Avenue Mauritius, which is regulated by the Financial Services Commission of Mauritius. We help traders and Introducing Brokers achieve their business goals and personal ambitions. Our business is built on integrity and trust, offering an industry leading combination of dynamic products, competitive trading parameters and premium, one-on-one service.

It is Vantage Trading's mission to enable the personal ambitions and business goals of FOREX traders and IBs, through underpinning dynamic products with competitive trading parameters and a premium customer experience.

Vantrading Ltd, is a company registered in the Republic of Cyprus and whose Registered office is at Archiepiskopou Makariou III,160, 1<sup>st</sup> floor, 3026, Limassol, Cyprus. Vantrading Ltd facilitates services, including but not limited to payment services, to Vantage Trading Ltd.

2. COMMITMENT

Vantage Trading is committed to protecting the privacy of all personal information which it obtains from you, including the information obtained during your visits to this website or the provision of other services to you. Vantage Trading will only use your personal information in accordance with this Privacy and Security Policy and otherwise in accordance with the Privacy and Data Protection Act in Mauritius.

3. VANTAGE TRADING COLLECT PERSONAL INFORMATION

Vantage Trading collects certain personal information in order that it may meet the needs of its customers. By collecting certain personal information, Vantage Trading can monitor and improve the services which it offers to its existing and potential customers. We will use this information for the following purposes: establishing and maintaining your account, providing our services to you, improving our services, regulatory notifications and marketing.

4. WHAT INFORMATION DOES VANTAGE TRADING OBTAIN?

Vantage Trading will collect and hold information about you when you complete an online application or other type of form or access and trade on your account through this website or another service, we provide to you. Vantage Trading may derive information from your use of this website or another service we provide to you and may store this information with your personal profile. This information may include site areas visited, pages viewed, frequency and duration of visits, types of transactions conducted, documents downloaded and other websites which may have referred you or to which you link.

5. HOW WILL VANTAGE TRADING USE THIS INFORMATION?

Vantage Trading may use such information for any one or more of the following purposes:

- to provide the services to you that you have requested including processing transactions.
- to confirm your identity.
- to maintain your personal profile; to manage your account.
  
- to contact you when necessary or appropriate in relation to the services being provided to you.
- to keep you updated whilst you are a customer in relation to matters such as contracts you have traded and activities of Vantage Trading.
- to manage and administer the products and services provided to you.
- to provide you with information regarding the products and services offered by Vantage Trading; to develop an understanding of the products and services that you may be interested in obtaining from Vantage Trading.
- to provide you with information or opportunities that we believe may be relevant to you.
- to tailor the website or other service we provide to you to your needs and interests; and
- to create anonymized statistical data.

You consent to Vantage Trading using your personal information for the above-stated purposes. You also consent to Vantage Trading transferring your personal information out of Mauritius where this is necessary for Vantage Trading to fulfill its contractual obligations to you. Please note that Vantage Trading only transfers personal information to organizations out of Mauritius if Vantage Trading has assessed the organization as having appropriate controls and safeguards in place to protect your personal data.

6. WHO MAY VANTAGE TRADING DISCLOSE THIS INFORMATION TO?

Vantage Trading may be required to provide your personal information to the regulator and government bodies from time to time. Vantage Trading may also disclose your personal information to:

- financial institutions and other similar organizations that deal within the course of its corporate activities, or those that are nominated by you.
- external service providers and professional advisers (which may be located overseas) that provide services to Vantage Trading.
- any organization at your request or any persons acting on your behalf, including your financial adviser, broker, solicitor, or accountant.
- any third parties where this is necessary to process a transaction or provide services which you have requested; or
- any authority to whom Vantage Trading is required to disclose such information by law. Please note that Vantage Trading does not sell or provide your personal information to third parties for marketing purposes.

## 7. UPDATING YOUR INFORMATION

You may inform Vantage Trading at any time that your personal details have changed or that you wish Vantage Trading to delete personal information we hold about you by emailing us at [support@vantagetradings.com](mailto:support@vantagetradings.com). Vantage Trading will change or delete your personal information in accordance with your instructions, except to the extent that we are required to hold your personal information for regulatory or legal purposes, to provide you with the services you have requested or to maintain adequate business records.

## 8. LINKS

## 9. COOKIES

Vantage Trading uses cookies to gather information about your access to this website and other services we provide to you. Measures include encryption of data during transmission, strong authentication mechanisms and secure access to machines and data.

You need not give us any of the personal information requested by Vantage Trading. However, without that information, Vantage Trading may be unable to open an account for you, where the information is requested in an application form, or to provide you with any other services, information or assistance you have sought. Should you have any questions or complaints about your privacy please contact us. If a complaint is not resolved by Vantage Trading to your satisfaction, you may complain to the Information Commissioner.

Under data protection legislation, you have (subject to certain exceptions) the right to obtain copies of any personal information which Vantage Trading holds about you and to inform Vantage Trading of any inaccuracy.

If you have a request, please contact us to obtain a subject access request form.

We may charge a nominal fee to cover the cost of verifying the application and locating, retrieving, reviewing, and copying any material requested.

## 12. YOUR CONSENT

By accessing this website or other service we provide to you, you consent to Vantage Trading collecting, maintaining, using, and disclosing personal information about you and provided by you or by another person as described above.

## 13. AMENDMENTS TO POLICY
