

SNS Terms of Use

1: About These Terms of Use

These terms establish the rules for using the social networking service or social networking site (hereinafter referred to as "SNS") operated by Vantage Trading or its affiliated companies (hereinafter referred to as "Vantage Trading").

2: Purpose of Use

Vantage Trading uses the official SNS to disseminate information to users (as defined in clause 3).

3: Users

A "user" refers to anyone who views or uses Vantage Trading's official SNS.\ By viewing or using Vantage Trading's official SNS, the user is deemed to have agreed to these terms.

4: Scope of Application and Changes to These Terms

These terms apply to Vantage Trading and users regarding the provision and use of Vantage Trading's official SNS.\

Vantage Trading may change these terms without prior consent from users. The revised terms will be posted on Vantage Trading's website and will take effect upon posting.

5: Prohibited Actions

Users shall not engage in the following actions (including actions that may lead to such) when using the service:

- (a) Actions that infringe upon the rights or interests of Vantage Trading, other users, or third parties;
- (b) Actions that defame, insult, damage the reputation, credit, privacy, etc. of Vantage Trading, other users, or third parties (including disclosing information that could lead to the identification of individuals such as email addresses, phone numbers, addresses, etc. of Vantage Trading, other users, or third parties), or interfere with their business;
- (c) Actions that violate the Public Offices Election Act;
- (d) Actions that solicit membership to religious groups or other organizations;
- (e) Actions that solicit investments, donations, funding, or the purchase of goods or services;
- (f) Actions that introduce or solicit viewing of other websites deemed inappropriate by Vantage Trading;
- (g) Actions that use information obtained through Vantage Trading's official SNS for commercial purposes without Vantage Trading's approval;
- (h) Actions that transmit viruses or other harmful programs or files that interfere with the normal function of computers' software or hardware to Vantage Trading, other users, or third parties through Vantage Trading's official SNS;

- (i) Actions that post information or content on Vantage Trading's website and apps without proper authority;
- (j) Actions that interfere with the provision and use of Vantage Trading's official SNS by Vantage Trading, other users, or third parties;
- (k) Actions that access Vantage Trading's website and apps through unauthorized means such as hacking, or monitor or copy all or part of them; and
- (l) Other actions that violate the SNS terms of use, public order and morals, laws or penal regulations, or that Vantage Trading deems inappropriate.

6: Post Deletion Criteria

If a user of Vantage Trading's official SNS violates these terms, Vantage Trading may delete the user's posts or restrict the user's access to Vantage Trading's official SNS, and the user shall not object to this.

Vantage Trading does not guarantee or approve the content of information provided by users through Vantage Trading's official SNS. Therefore, Vantage Trading bears no responsibility for any damages incurred by users who relied on such content.

If a user of Vantage Trading's official SNS violates these terms and causes tangible or intangible damage to Vantage Trading, other users, or third parties, the user shall compensate for this at their own responsibility and expense, seek other resolutions, and shall not cause any burden or inconvenience to Vantage Trading.

The copyright of information posted by users through Vantage Trading's official SNS belongs entirely to Vantage Trading, and users shall not exercise their moral rights as authors regarding this information. Users have no right to claim compensation for the attribution and waiver of these rights.

7: Disclaimer

Vantage Trading may change the content of these terms of use without obtaining consent from users. In such cases, the revised terms will take effect immediately upon Vantage Trading's posting on the website or other means of announcement, and users will be subject to the revised terms.

Vantage Trading does not guarantee the accuracy or validity of any information provided on Vantage Trading's official SNS.

Vantage Trading bears no responsibility for any damages or troubles incurred by users related to the various information displayed on Vantage Trading's official SNS, or changes and updates to the display of such information. Furthermore, Vantage Trading shall not be responsible for any damages, losses, or disadvantages arising from the use of Vantage Trading's official SNS, regardless of the legal basis for the claim.
